

**Classic Motown Bundle Sweepstakes Prize Draw**  
**TERMS AND CONDITIONS**

Promoter's decisions are final and binding in all matters relating to the Classic Motown Bundle Sweepstakes Prize Draw; referred hereafter as the "Prize Draw".
