

Classic Motown Prize Draw TERMS AND CONDITIONS

NO PURCHASE NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

Promoter: Universal Music Enterprises (“UMe”)

Promoter’s decisions are final and binding in all matters relating to the Classic Motown Prize Draw; referred hereafter as the “Prize Draw”.

Prize Draw Entry Period: Prize Draw begins at 12:00 a.m. PST on the 13 of November 2017 and ends at 11:59 p.m. PST on the 21 of November 2017 (“Prize Draw Entry Period”).
